Sir,

The Standing Committee Inspection Reports (SCIRs), Departmental Inspection Reports (DIRs) and Supplementary Inspection Reports (SIRs) forwarded by you were scrutinised at this Directorate General and recommendations of DGET were placed before the members of the Sub-Committee of NCVT dealing with affiliation in its meeting held on 15.10.1997 at DGET Headquarters, New Delhi. The recommendations of the Sub-Committee made in the meeting on various issues would be issued shortly. A copy of the Statement containing affiliation approval/status for various ITIs/ITCs/Units/Trades with remarks etc., duly signed is enclosed.

On the basis of the above statement, you may please issue the affiliation orders to the Management of the concerned ITIs/ITCs for Trades/Units. In respect of cases where there are deficiencies action be take as under:-

- i) Defects and deficiencies observed, under "Remarks" column 6 are made good within six months i.e. latest by 15th April, 1998 failing which the trainees of such trades/units may not be allowed to appear in the All India Trade Test (AITT) for Craftsmen of July, 1998.
- ii) The conditions of affiliation, if any, are complied with.
- iii) It has been resolved in the meeting that the cases kept "Under Consideration" would be accorded affiliation with the NCVT from the date of their pre-inspection/Standing Committee Inspection, as soon as deficiencies by the institutes are made up i.e. the date of affiliation is to be reckoned from the pre-inspection/ Standing Committee Inspection date for the purpose of declaration of the result. The decision conveyed earlier vide DO letter No. DGET-18017(40)/96-Misc.-TTC dt. 10th July, 1997 may also be kept in view while declaring the result.






